## BOOK NOTES

**BAR EXAMINATION AND REQUIREMENTS FOR ADMISSION TO THE BAR.** By James E. Brenner and others. Colorado Springs: Shepard's Citations, 1952. Pp. xvii, 498. \$5.00.

This book was published for the Survey of the Legal Profession under the auspices of the American Bar Association. It contains the reports of the Consultant and the Advisory and Editorial Committee on Bar Examinations and Requirements for admission to the Bar. The reports deal in detail with requirements for admission to the bar in the various states, the federal courts and in England, Ireland, Canada, Australia and New Zealand. Included are discussions of bar examinations as testing devices and of the question of a national bar examination.

**FOURTH COPYRIGHT LAW SYMPOSIUM.** New York: American Society of Composers, Authors and Publishers, 1952. Pp. xvii, 178.

Five selected papers from among those submitted in the annual Nathan Burkan Memorial Competition are published in this volume. Their titles are: "Inroads on Copyright Protection" "The Compulsory Manufacturing Provision: An Anachronism," "The Manufacturing Clause: Copyright Protection To the Foreign Author," "The Doctrine of Moral Right and American Copyright Law: A Proposal" and "Copyrights and the Income Tax Problem."

**NEW YORK STATE LEGISLATIVE ANNUAL.** New York: New York Legislative Service, Inc., 1951. Pp. v, 393. \$7.50.

This volume contains background material on bills introduced in the New York legislature. Included are messages of the governor, committee reports and memoranda filed by members of the legislature, state agencies and private organizations.

**THE FEDERAL INCOME TAX.** (2d ed., 1951, with 1952 Supplement). By Joyce Stanley and Richard Kilcullen. New York: The Tax Club Press, 1951. Pp. xviii, 374, 11 (Supplement). \$7.50.

A section by section discussion, in readable language, of the most important provisions of the Internal Revenue Code, with reference to applicable Treasury Regulations and selected cases, this book has become the basic elementary text in this field.
