April the twenty-ninth has been designated as Law School Day by the Board of Curators of the University of Missouri, and the day will be devoted to various activities of special interest to students and alumni of the School of Law. All former students and friends of the School of Law are invited and urged to be present.

At ten o'clock in the morning, Mr. Taylor Sandison, president of the Law Alumni Association, will address the students and alumni in Tate Hall. At two o'clock in the afternoon, the members of the Law School Foundation and the trustees of the Foundation will hold their annual meetings. At four o'clock, the

Order of the Coif will hold its annual meeting at which Judge Cornelius H. Skinker, of Bolivar, Missouri, will be tendered honorary membership. He will be presented by Judge Laurance M. Hyde, last year's honorary initiate. At this meeting also the members of the senior class who have been elected to regular membership will be initiated into the Order.

During the evening, the thirty-ninth annual banquet will be held at the Knights of Columbus Hall, College and Bass Avenue. There will be several distinguished speakers at the banquet. This year is the tenth anniversary of the Class of 1929, and most of its members are expected to be present.

On the evening of March 18, the University of Missouri Law School Foundation gave a banquet in honor of the student members of the Editorial Board of the *Missouri Law Review*.
