## News of the Law School

The desirability of all law students spending part of their summer vacations, and especially at least two months between the second and third years, as apprentices in established law offices has been formally recognized by the faculty, which urges every student to undertake this experience. At present such apprenticeship is not compulsory nor recognized in credit for graduation, but the School of Law will co-operate with the stu-

dents in every way to enable them to find openings in law offices. The success of this experiment must depend in a large degree upon the bar of the state, and particularly the alumni and friends of the school, in making places for these men in their offices and in taking an interest in their work. Since this is regarded as part of the student's legal education, it is not contemplated that they should receive any remuneration for the services they can perform.
