Friends and alumni of the law school are reminded again that the last Saturday in April, which is April 27th, has been designated as Law Day at the University of Missouri, and that they are all cordially invited to participate in the activities of that occasion. In the afternoon the

Honorable Kenneth Teasdale of St. Louis will be initiated as honorary member of the Order of the Coif, and in the evening he will be the principal speaker at the dinner held in the Knights of Columbus Hall. Mr. Teasdale received his LL.B. from the University of Missouri in 1918, was formerly president of the St. Louis and the Missouri Bar Associations, and is chairman of the Supreme Court Committee on Practice and Procedure, member of the House of Delegates to the American Bar Association, and chairman of the Association Committee on Legal Service Bureaus.
