LAW SCHOOL NOTES

JAMES LEWIS PARKS PRIZE—As a memorial to the Honorable James Lewis Parks, formerly Dean of the Law School, the Trustees of the University of Missouri Law School Foundation have established a prize of \$50 to be rewarded to the student enrolled in the Law School who does the best work and attains the best scholastic standing in some course to be designated by the faculty at the beginning of each academic year.

For the academic year 1948-1949 the faculty has designated the course in Security Transactions, a course Dean Parks taught, as the one in which this prize is to be offered.
