UNIVERSITY OF MISSOURI LAW SCHOOL FOUNDATION

When the University of Missouri [Columbia] Law School Foundation was established as a pro forma corporation on April 17, 1928, its stated purpose was as follows: "The corporation is formed for the purpose of promoting and furthering legal education in the State of Missouri. It proposes to accomplish its objects by establishing an endowment and foundation for promoting the interest and welfare of the School of Law of the University of Missouri [Columbia], and for aiding and extending the work and activities of said School of Law."

Law School Foundation support of the Dean and Faculty of Law has been of significant help in certain areas where public funds have been unavailable or inadequate. The following are some of the Foundation's programs.

Travel Expense Reimbursement. It is important that as many law teachers as possible attend the annual meeting of the Association of American Law Schools held each year shortly after Christmas day. Public funds have been available to cover only transportation costs and often have been inadequate for that. For some years the Foundation has provided additional funds to cover meals, lodging, and excess transportation costs, and \$1,250 will be used for this purpose in 1973-74.

Summer Faculty Fellowships. For some years the Foundation has authorized the expenditure of up to \$4,500 for up to five \$900 summer faculty fellowships, with no strings attached. Two or three are awarded in a typical summer, but with a larger faculty and no significant increase in the summer school budget, it is expected that more members of the law faculty will be awarded summer fellowships. The faculty member usually does legal research for law review articles or books, or develops new or improved teaching materials. For example, Professor Grant S. Nelson is co-editor of the recently published and nationally recognized *Van Hecke, Leavell & Nelson, Cases and Materials on Equitable Remedies and Restitution* (2d ed. 1973), and a Foundation summer fellowship helped give him the released time he needed for this very significant contribution to legal scholarship.

Dean's Discretionary Fund. For some years the Foundation has provided the Dean of the School of Law with a \$750 discretionary fund which can be used for certain entertainment expenses not reimbursable from public funds, or for other purposes consistent with Foundation objectives.

F. L. Thompson Jr. Faculty Achievement Fund. In December 1972 F. L. Thompson Jr. [1949] of Kansas City made a substantial gift of stock to the University, the income (and principal at discretion) to be used at the direction of the Foundation for a faculty achievement program. The Foundation Trustees will determine this fall the particular program under which exceptional faculty achievement is to be encouraged, recognized, and rewarded.
